THE INTERIM GOVERNMENT'S (IG) COMPLEMENTARY COMMITMENT (CC) POLICY

-IG's CC Policy-

Definition

Mutual symbiotic COMPLEMENTARY COMMITMENT on Diaspora-Ground Zero (GZ) relationship in the prosecution of the Ambazonian Liberation Struggle.

Premise

- -Acknowledging that Diaspora and GZ have distinct indispensable but complementary roles in the prosecution of our Liberation Struggle;
- -Reiterating the IG's position on the total and unconditional independence of Ambazonia;
- -Cognizant of the need to pre-emptively ensure our readiness anytime to negotiate the terms of separation from La Republique du Cameroun (LRC) from a point of strength.

Concept

The CC policy conceptualizes diaspora's *Commitment to Complement* the efforts of GZ and deny LRC military victory.

By this policy, diaspora's patriotic engagement to the quickest pathway to liberation, proven through an effective COMMITMENT of all diasporans to civic responsibilities:

- OALRE
- Compulsory Independence Due (CID);
- Ambazonia Restoration-Fee (AR-FEE);
- Ambazonian Communication Tariff (ACT);

will represent diaspora's obligatory commitment to liberate homeland.

The aim is to generate resources to COMPLEMENT GZ's COMMITMENT for the implementation of Ambazonia Restoration Forces (ARF) Firepower and Civil Society Resistance (CSR). These aforementioned tools are indispensable to fight the enemy, LRC, on a 360-degree perspective, get LRC's Genocidal Military to submission and speedily void our territory of colonial administrative bondage.

Responsibility

Diaspora's commitment should not be aimed at nor perceived as controlling GZ. Diaspora will accountably COMPLEMENT GZ's actions geared at taking control of our rightful possession as a people - Ambazonia and her natural resources, in line with the IG's Accountability and Action (AA) policy.

Caution

Any diaspora mindset or machinations contemplating controlling GZ from abroad, to fight the enemy on the ground, is pure armchair parasitism and manipulative positioning on GZ from opportunists. This mindset cannot be tolerated, hence, must be highly discouraged and condemned in order to foster and encourage unity of purpose and concrete collaboration between stakeholders both in the diaspora and in GZ in different domains of prosecution of our Liberation Struggle, in line with the IG's Building Bridges (BB) policy.

Conclusion

The IG is fully COMMITTED to generating resources to COMPLEMENT GZ's efforts in resisting LRC's genocidal annihilation war by defending homeland through ARF firepower escalation and civil society resistance against LRC's colonisation.
