Presidential Executive Order FRA03/05042024

To Ambazonian Civilian Population in Ground Zero and Diaspora

## SUBJECT: TOTAL REJECTION AND BAN OF CAMEROUN'S 2025 PRESIDENTIAL ELECTION ACTIVITIES IN AMBAZONIA

Considering that Southern Cameroons – Ambazonia's Independence is backed by UNGA Resolution 1608, by the ruling of the Banjul court case "Southern Cameroons Vs La République du Cameroun" and by the ruling of the Bamenda High Court HCB28/92 which established that La République du Cameroun is an "illegal forceful occupier" of the territory of Ambazonia; *Ambazonia is and should be recognized and respected as SEPARATE nation from La République du Cameroun;* 

Reminding that the respect of the sanctity of borders attained at independence is backed by article 4b of the African Union Constitutive Act. In fact the African Bar Association (AFBA, 2020) cited, "African countries have agreed on one fundamental principle: that only by respecting boundaries inherited from colonisation can there be peace in Africa. This was emphasized in the Cairo Declaration of July 24, 1964; the Algiers Declaration of July 1999 and is entrenched in the African Union Constitutive Act, Article 4(b)". Reminding further that La République du Cameroun has ratified the African Union Constitutive Act, meaning that her treaty obligations compel her to respect her boundaries acquired at independence on 1st January 1960; La République du Cameroun's presence in Ambazonia is an illegal INVASION and a breach to the international law sanctioning the territorial integrity, inviolability and sovereignty of Ambazonia;

Affirming that the right to political, economic and social freedom embodied in the principle of equal rights and external self-determination of peoples, is inalienable, enshrined in the UN charters and backed by International Law; La République du Cameroun's attempt to conduct presidential election in a foreign territory is illegal and a VIOLATION of the right to political freedom of the Ambazonian people;

In line with the aforementioned, LA RÉPUBLIQUE DU CAMEROUN CANNOT HOLD ELECTIONS IN THE AMBAZONIAN TERRITORY. To be absolutely clear, La République du Cameroun's elections should be conducted within the confines of her internationally recognized borders attained at her independence on 1/1/1960, with participation limited to La République du Cameroun citizens.

Ambazonians and the International Community are hereby unequivocally and unapologetically informed that all La République du Cameroun's orchestrated activities related to planning, publicity, campaigns, poll settings, electioneering, and voting for the La du Cameroun's 2025 Presidential elections République are acrimoniously, vehemently and indefinitely REJECTED and BANNED in the Ambazonian Territory, effective today Friday the 5th of April 2024.

Any violation of this ban will be subjected to ancestral and divine justice by the ARF+.

Anyone claiming to represent our country, Ambazonia in a foreign parliament in Yaoundé or anyone participating in any activity related to La République du Cameroun's presidential elections in the Ambazonian territory, is putting themselves in the class of "Allies and Agents of the invading enemy - La République du Cameroun" and becomes a legitimate and pre-warned ARF+ target covered by the Presidential directives for the Daring Move upgrade.
